Aim: The purpose of this contract is to perform functions of:

- Illustration for 2D animation
- -Audiovisual narrative design
- -Graphic and corporate design for video games and educational product

Requirements of the candidate:

Be at least sixteen years of age and have not reached the legally established retirement age.

Not suffer from illness or be affected by physical or mental limitations that are incompatible with the performance of the corresponding functions. The proposed applicants must undergo a medical examination by the Prevention Service contracted by the University of Burgos.

Not have been separated, through disciplinary proceedings, from the service of any of the Public Administrations, nor be disqualified from performing public functions.

Nationality: Spaniards and nationals of Member States of the European Union may participate in this call, who will enjoy the same treatment and the same effects as Spanish nationals. These provisions will also apply to nationals of those States to which, by virtue of International Treaties concluded by the European Union, the free movement of workers is applicable in the terms in which it is defined in the Constitutive Treaty of the European Union. European Community. This contract will not be subject to conditions or requirements based on nationality. This possibility will always be understood to be conditional on applicants for nationality from countries that are not members of the European Union being in Spain in a legal situation, holding a document that enables them to reside and be able to access the labor market without limitations or that can obtain work authorization or exception to authorization.

- Degree: Being in possession of the degree required in the specific requirements, or proof of having paid the rights for its issuance. In the case of qualifications obtained abroad, the documentation proving their homologation or recognition must be attached.
- Not be involved in any of the prohibitions that for obtaining the status of beneficiary are included in article 13 of Law 38/2013, of November 17, General Subsidies.
