Aim:

- Collaboration in proposals, applications, follow-ups, and closure of projects.
- Data managements and analysis for programs and papers development.
- Collaboration in teaching tasks.
- Communication with international partners (English)
- Collaboration in the creation and development of dissemination actions.
- Planification of dissemination events.
- Collaboration in research and events carried out by the university (conferences, promotional weeks, etc.).

Requirements of the candidate:

### **GENERAL REQUIREMENTS**

- Aged between 16 years and retirement age ruled by law.
- Lack of sickness or handicap for proper development of duties. The candidates will comply with medical check by the Prevention Service hired by University of Burgos.
- Not to have been dismissed, by means of disciplinary proceedings, from the service of any of the Public Administrations, nor to be disqualified from the performance of public functions.
- Nationality: Spanish nationals and nationals of Member States of the European Union may participate in this call for applications, who will entail the same treatment and the same effects as Spanish individuals. These provisions shall also apply to nationals of those States to which, by virtue of International Treaties concluded by the European Union, the free movement of workers is applicable in the terms defined in the Treaty establishing the European Community. This contract shall not be subject to conditions or requirements based on nationality. This possibility will always be understood to be conditional on applicants with nationality from countries that are not members of the European Union being in Spain in a legal situation, being holders of a document that enables them to reside and to be able to have unrestricted access to the labour market or to be able to obtain a work permit or exemption from work permit.
- Qualification: To be granted with the qualification required in the specific requirements, or proof of having paid the fees for its issue. Not being subject to any of the prohibitions

for obtaining the status of beneficiary set out in article 13 of Law 38/2013, of 17 November on General Subsidies.

### **SPECIFIC REQUIREMENTS**

Those who meet the following requirements are eligible to apply:

- Graduate in Human and Social Sciences or Health Sciences. PDI GRADUATE R1a.
- Language level C1 (English).

Duration: The project deadline is December 31<sup>st</sup>, 2025, unless the project were extended.

Gross monthly remuneration: 750€
