Aim: To develop a functional application that supports the analysis of care centres and services for people with autism according to the criteria and indicators foreseen in the 2022-2023 revision of the Quality of Life Indicators Guide for people with ASD (OTEA).

Requirements of the candidate:

General requirements:

- Be sixteen years old and not have reached the legally established retirement age.
- Not suffer from any illness or be affected by any physical or mental limitation that is incompatible with the performance of the corresponding duties. The proposed candidates must undergo a medical examination by the Prevention Service contracted by the University of Burgos.
- Not to have been dismissed, by means of disciplinary proceedings, from the service of any of the Public Administrations, nor to be disqualified from the performance of public functions.
- Nationality: Spanish nationals and nationals of Member States of the European Union may participate in this call for applications, who will enjoy the same treatment and the same effects as Spanish nationals. These provisions shall also apply to nationals of States to which, by virtue of international treaties concluded by the European Union, the free movement of workers as defined in the Treaty establishing the European Community applies. This contract shall not be subject to conditions or requirements based on nationality. This possibility will always be understood to be conditional on applicants of non-European Union nationality being in Spain in a legal situation, being holders of a document that enables them to reside and to have unrestricted access to the labour market or to obtain work authorisation or an exception to the authorisation.
- Qualification: To be in possession of the qualification required in the specific requirements, or proof of having paid the fees for its issue. In the case of qualifications obtained abroad, the documentation accrediting their homologation or recognition must be attached.
- Not to be subject to any of the prohibitions for obtaining the status of beneficiary set out in article 13 of Law 38/2013, of 17 November on General Subsidies.



Specifics requirements:

- High school degree or vocational training.

Duration: Until 30 june 2023

Gross monthly remuneration: 830€

Application submission deadline: The deadline for submitting applications will be four working days from the day following the publication of this call for applications on the University's electronic notice board.

Documents to be provided:

- Copy of qualification requested in the call for applications.
- Academic certificate of the required qualification.
- Any other documentation that can accredit the criteria required in the call for applications.
