Aim: The purpose of this contract is to perform functions of:

- Design, Planning, Management, Development, Execution, Justification, Diffusion and Dissemination Tasks of the "ESIRA: PROMOTION OF SOCIAL INNOVATION IN RURAL AREAS" Project. All documentation and procedures related to the project will be carried out in English.
- Preparation of materials, resources, content and actions, both in person and online, to carry out the aforementioned Project. Participation and preparation of dissemination and training activities, workshops, projects and initiatives, in person and online, specific to the project. Design and Assistance in the Project Actions.
- Promotion of the design of Innovative Social Economy Initiatives, through multi-actor participatory methodologies in the Rural Territory. Maintenance of coordination with the European project partners and with the European Commission officials responsible for the project.
- Research based on the results, participation in the publications derived from it and Administrative Management of the Project and collaboration in the preparation of the Report and in the Justification of the same. Management and updating of the Project website and Social Networks associated with the Project.

Requirements of the candidate:

Be over sixteen years of age and have not reached the legally established retirement age.

Not suffer from illness or be affected by a physical or mental limitation that is incompatible with the performance of the corresponding functions. The proposed applicants must undergo a medical examination by the Prevention Service contracted by the University of Burgos.

Not having been separated, through disciplinary proceedings, from the service of any of the Public Administrations, nor found disqualified from performing public functions.

Nationality: Spaniards and nationals of Member States of the European Union may participate in this call, who will enjoy the same treatment and the same effects as Spanish nationals. These provisions will also apply to the nationals of those States to which, by virtue of International Treaties concluded by the European Union, the free movement of workers is applicable in the terms in which it is defined in the Treaty Constituting the European Union. European Community. This contract will not be subject to conditions or requirements based on nationality. This possibility will always be understood conditional on the applicants for nationality from non-member countries of the European Union being in Spain in a legal situation, being holders of a document that enables them to reside and to be able to access the labor market without limitations or that can obtain work authorization or exception to authorization.



Qualification: Being in possession of the title required in the specific requirements, or proof of having paid the fees for its issuance. Not be subject to any of the prohibitions that for obtaining the status of beneficiary are included in article 13 of Law 38/2013, of November 17, General Subsidies.

Specific requirements Those people who meet the following requirements may apply for the position: Be in possession of a Higher Education Qualification (Degree, Bachelor's Degree or equivalent), preferably in Economics and Business Sciences, Sciences, Environment, Social Sciences, Engineering or equivalent. • Certificate of English language knowledge C1 or higher.
