If you don't need a Visa, you should only request for a Codice Fiscale (identification number) to the Italian Embassy or Consulate in your country or, once in Italy, to the <u>Agenzia delle Entrate office</u>.

If needed, students have to apply for a student visa at the Italian Consulate of their home country before their arrival in Rome. Students who need a visa will receive a letter of invitation as soon as they have submitted their application documents and have been admitted.

N.B.: If you have a non EU citizenship you need a VISA even if you are enrolled in a EU university.
